### EDUCATION QUALIFICATION:

Minimum educational qualifications for employment are given below

Candidates should have passed qualifying degree (diploma/ certificate examinations in relevant disciplines. All the qualifications should be full time regular course/s from AICTE approved / UGC recognized University/Deemed University. The courses offered by Autonomous Institutions should be equivalent to the relevant courses approved /

by Autonomous institutions snould be equivalent to the relevant courses approved / recognized by Association of Indian Invirestities (AlU)UGC/AICTE. Candidates (belonging to General and OBC-NC category) should have secured minimum 60% (aggregate marks) in qualifying degree/diploma/certificate examinations, relaxed to 50% (aggregate marks) for SC/ST/PWD candidates. ## B. CONCESSIONS/ RELAXATIONS:

Reservation of posts for SC, ST and OBC-NC are as per Government Directives. 3 % of the identified vacancies will be reserved for PWD (Persons with disabilities – with degree of disability 40% or above). Example for post of laboratory assistant, candidates with disability of either one arm or one leg are only eligible.

The reserved category candidates are required to submit the original caste/ PWD certificate/s in prescribed format of Government of India, issued by the competent authority at the time of interview/s, in support of their claim. ## C. SELECTION METHODOLOGY

Candidates fulfilling all of the above eligibility criteria for respective positions will be called for a Written Test comprising of General Aptitude Test and Technical / Professional Knowledge. The Written Test is likely to be conducted at 5 Centers. i.e., Mumbai, Vishakhapatnam, Kolkata, Chennai & Delhi However, HPCL reserves the right to cancel or add any Center.

Candidates may be called for written test at any center other than his/her choice. Candidates qualifying in the Written Test will be called for Personal Interview/s, in order of the category-wise and position wise merit list of the Written Test in a predetermined ratio. While drawing merit list of successful candidates, 85% weightage would be given to performance in written test and 15% to Personal Interview/s. Candidates will have to qualify through each

stage of selection process successfully before being adjudged as suitable for selection.

All candidates who qualify in the Personal Interview/s and also obtain minimum qualifying marks in the combined scores of written test & personal interview/s will be required to undergo pre-employment medical examination as per the Corporation's policy.
